Extended Day Policies and Procedures –Please Read Carefully and Initial:

Parent Initial:

✓ Full payment is due the first day of each week your child attends the program. All fees are weekly and non-refundable. There are no daily rates.

✓ If full payment is one week overdue your child may not attend the program until the balance is paid.

✓ A non-sufficient fund fee is charged for all returned checks. If fee is not cleared timely your child will no longer be able to attend the program. Checks will no longer be accepted. Payments must be made via cash or money order.

✓ A Late Fee of \$1.00 per minute, Per Child, will be charged for all pickups after 6pm. Consistent late pick up may warrant the child's exclusion from the program.

✓ As the legal guardian of the enrolled (named) student I hereby give my consent for him/her to participate in any activities during the program, including but not limited to computer internet use.
